# **BURIAL INFORMATION**

## WHAT TO DO IN THE EVENT OF A DEATH

#### I. REPORT THE DEATH

Report the death to the BC Muslim Association Director in Charge of Burial immediately.

## 2. MEDICAL REPORT

(A) Request the attending physician to complete a Physician's Medical Certification of Death form.

(B) If the person has passed away at home or is a coroner's case please provide the name of the Coroner, the name of the Police Officer and the case numbers.

## 3. DECEASED INFORMATION - FOR BURIAL PERMIT AND REGISTERING THE DEATH

Registration of Death form must be filled by the BCMA funeral director during the arrangement interview with the information provided by the legal representative/next of Kin in order obtain the burial permit. The following information and relevant documents will be requested:

- a. Citizenship/ birth certificate
- b. Passport or a picture ID
- c. Health care card or proof of number
- d. Social insurance card or proof of number
- e. Full legal name of the deceased
- f. Date of death
- g. Full address of the place of death
- h. Full address of the place of residence
- i. Marital status

- j. Full maiden name of spouse
- k. Occupation of the deceased
- 1. Birth date of the deceased
- m. Birth place of the deceased (city and country)
- n. Father's full name
- o. Father's place of birth (city and country)
- p. Mother's full name including maiden name
- q. Mother's place of birth (city and country)
- r. The full name, address and relation of the informant

### 4. GHUSL (Washing)

The B.C. Muslim Association provides facilities for Ghusl at the *Richmond Jamea Masjid, Surrey Jamea Masjid* and *Burnaby Masjid ul Salaam*. There is a volunteer BCMA Men and Women Ghusl Committee who will assist the family in performing the ghusl under the supervision of a licensed funeral director. Please note that a maximum 2 family members and 2 BCMA guides for a total of 4 people will only be allowed into the ghusl room.
