For your convenience the following are the accepted methods of payment:

- Mail in the request form with a check for the total amount of \$13,200.00 made payable to the BCMA Burial, mail to BCMA Funeral Services 12300 Blundell Road Richmond BC V6W 1B3.
- Mail in all monthly post dated checks with the completed request form to BCMA Funeral Services 12300 Blundell Road Richmond BC V6W 1B3. Checks are made payable to BCMA Burial.
- In person with appointment for cash, at BCMA Funeral Services Head Office 12300 Blundell Road Richmond BC V6W 1B3.
- Submit the completed request form and the BCMA Preauthorized Debit Form attached with your voided check copy (withdrawals on the 15 day of each month)
- Submit the request form and then send an electronic transfer to [etransfer.burial@thebcma.com](mailto:etransfer.burial@thebcma.com) (please include a descriptive message in the memo section for the etransfer example: "applicant name" – payment for victory burial plot)

**Terms and Conditions**

1. The grave(s) shall not be assigned or transferred to any other person without the express permission of the BC Muslim Association.
2. If the BC Muslim Association consents to the assignment or transfer of the grave(s), then such assignment or transfer shall only be made to a Sunni Muslim.
3. In the event the BC Muslim Association refuses any assignment or transfer, then the BC Muslim Association may, at its option, purchase the said grave(s) at its original cost.
4. The BC Muslim Association reserves the right to refuse any interment (burial) at the burial site unless the Association's rules of burial procedures, as set forth by the religious board of the BC Muslim Association, are strictly adhered to.
5. The terms and conditions of this grave(s) shall be binding upon and shall ensure to the benefit of the parties hereto and their respective successors and permitted assigns.
6. The purchaser agrees and understands that the BC Muslim Association only permits names and dates on the specified standard name plate marker and strictly prohibits any pictures, additional writings, sayings or emblems.
7. The purchaser agrees and understands that the funeral services for these burial plots will only be rendered by the BCMA Funeral Services or the BCMA approved contracted Funeral Home for outside lower mainland locations.

I hereby declare that I am a Sunni Muslim and I agree to abide by the burial rules, regulations and guidelines of the BC Muslim Association.
