This document is prepared to guide the members with regards to the upcoming 2023 BCMA Elections. The Appendix A on page 2 lists the names and numbers of the BCMA branches and chapters. Please follow these guidelines and do not hesitate to contact us should you require any assistance. The procedure is geared towards an electronic process but members may choose to print and fill in by hand if they wish. If you require assistance please contact election2023@thebcma.com

- 1) Nomination Form M37: The nominee (person running for election) fills up his/her section of the form;
- 2) Confidentiality Agreement Form M15: same as (1);
- 3) Oath of Office Form M39: same as (1);
- 4) Personal Profile Form M38: same as (1);
- 5) After completing his/her section of the above four forms, the nominee forwards it to his/her first nominator/witness to complete all forms except Form M38;
- 6) The first nominator returns the form back to the nominee after completing;
- 7) The nominee forwards the returned forms to the second nominator;
- 8) The second nominator completes his/her section and returns it back to the nominee;
- 9) The nominee shall check for accuracy and ensure that ALL fields of all forms have been completed;
- 10) The nominee shall Print to PDF pages 8-11 of the completed forms and name the file as [Branch/Chapter number Name of nominee]. For example, file name 24 Mohammed Ali will be for Mohammed Ali of Abbotsford;
- 11) Email the fully completed forms to <u>election2023@thebcma.com</u>. The subject line of your email shall be the same as the file name e.g. **24 Mohammed Ali**. Please ensure to copy both nominators or witnesses when emailing;
- 12) Steps 10 and 11 above also applies to those who have filled out on paper rather than online. Please scan pages 8-11 in above order, name and email as described above;
- 13) The Election Committee will acknowledge your email.

#### Notes:

- a) There is no objection if a nominator starts the above process instead of a nominee;
- b) You will need to continue replacing with the same file name each time until step 10;
- c) The nomination deadline is July 30,2023 as stated at the bottom of Form M37;
- d) All completed forms shall be emailed only to election2023@thebcma.com;
- e) If you have misplaced your membership card or unsure of your member number, please email member@thebcma.com;
- f) All membership renewals to be done online;
- g) See Appendix C for election dates.
